The focus of our Shredders Junior Locals Clinic is on learning snow sports fundamentals, skiing or boarding varied terrain and conditions, and most importantly, having fun. Because our Junior Locals Clinics are taught through our nationally recognized Children’s Ski School, we are pleased to offer the program to skiers of all levels ages 3 through 15 years, and boarders from 5 to 15 years. Each day’s program includes a morning and afternoon lesson and lunch as well as a *free* lift ticket and *free* rental equipment.

The 2010\11 Shredders will be a 5-week program, with an option to purchase extension days on other specified weeks (see below). Children skiing or riding on Saturday or extension days will be incorporated into daily Junior Elite lessons. Only Shredders participants will be eligible for this special discounted product!

EQUIPMENT RENTAL & FULL LIABILITY RELEASE AND INDEMNITY AGREEMENT

I accept for use from Taos Ski Valley, Inc. (hereinafter "Ski Company") **AS IS** the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for the replacement at full retail and loss of rental value of any equipment rented under this form, but not returned to the shop or which is damaged. I agree to return all rental equipment by the agreed date.

I understand and am aware that skiing on any type of equipment is a **HAZARDOUS** activity. I understand that the sport of skiing and the use of this equipment involves risks of injury to any and all parts of the user's body. I hereby agree that I freely and expressly assume and accept **ANY AND ALL RISKS** of injury or death and **PROMISE NOT TO SUE SKI COMPANY, the EQUIPMENT MANUFACTURERS or DISTRIBUTORS** (hereinafter jointly "PROVIDERS") for any such injury or death.

I understand that the downhill ski equipment (hereinafter "Ski") being furnished forms a part of or all of a ski-boot-binding system which **WILL NOT RELEASE** at all times or under all circumstances, and that it is not possible to predict every situation in which it will or will not release, and that its use **CANNOT GUARANTEE** the user's **SAFETY** or freedom from injury while skiing. I further agree and understand that the ski-boot-binding system may reduce but **DOES NOT ELIMINATE** the **RISK** of injuries to the user's legs and **DOES NOT REDUCE** the risk of injuries to the user's **KNEES OR** any **OTHER** parts of the user's body. In **SNOWBOARD** use, the binding system **WILL NOT** ordinarily release during use; these bindings are **NOT DESIGNED TO RELEASE** as a result of forces generated during ordinary operation.

I agree that I hereby **RELEASE PROVIDERS**, including all agents, employees, officers, directors, etc., from any and all responsibility or liability for personal injuries, death or damages to the user of the equipment (ski or snowboard) listed on this form. I agree **NOT TO MAKE A CLAIM AGAINST OR SUE** Providers for personal injuries, death or damages relating to skiing/snowboarding and/or the use of this equipment. I hereby **RELEASE** Providers from any such responsibility, whether it results from the use of this equipment by the user, or whether it arises or results from any cause, including **NEGLIGENCE** of Providers or any others or other liability arising out of the maintenance, selection, mounting or adjustment of this equipment or the user's participation in the sport of skiing/snowboarding. **I AGREE TO DEFEND, INDEMNIFY and HOLD HARMLESS PROVIDERS** if I ever violate the letter, spirit or intent of this Agreement and sue any of them for personal injuries, death or other damages, including but not limited to attorneys fees and costs.

In consideration for being able to rent this equipment, I hereby agree to accept the terms and conditions of this contract. This document constitutes the final and entire agreement between Providers and the undersigned. There are **NO WARRANTIES EXPRESS or IMPLIED**, which extend beyond the description of the equipment listed on this form. I **UNDERSTAND and AGREE** that I am responsible for obtaining life, accident and health **INSURANCE BEFORE** I or any minor participate in the sport of skiing.

If user is a **MINOR**, the undersigned parent/guardian signing below represents to Providers that they have the authority to enter into this contract on behalf of said **MINOR** and on behalf of any other parent or guardian of said **MINOR**, and in exchange for Provider making skiing facilities and this equipment available, the undersigned **AGREES TO DEFEND, INDEMNIFY AND HOLD HARMLESS PROVIDERS** from any claim for personal injury, death or property damage from said minor, even after the minor has attained majority, and to hold Providers, their representatives, agents, officers, directors and employees harmless from any claim, legal action, harm, injury, damages or loss to person and/or property made on behalf of the aforementioned minor or from third parties injured by the minor, including but not limited to attorney's fees and costs.

In exchange for, and in consideration of, Providers making this equipment and ski area available to the user for participation in the sport of skiing, I **CONTRACTUALLY AGREE** that any and all disputes between the user and Provider arising from use of this equipment or participation in the sport of skiing, and including any claims for personal injury and/or death, will be **GOVERNED BY THE LAWS OF THE STATE OF NEW MEXICO** and the **EXCLUSIVE JURISDICTION** thereof will be in the state or federal courts of the **STATE OF NEW MEXICO**. If any provision of this agreement is determined to be unenforceable, all other provisions shall be given full force and effect.

I, the undersigned, **HAVE READ AND UNDERSTAND** the terms of the above Full Release from Liability and Indemnity Agreement and I am signing it freely and of my own accord, realizing **IT IS BINDING** upon me, my heirs, assigns and, in the event I am signing it on behalf of **ANY MINORS**, that I have **FULL AUTHORITY TO DO SO REALIZING ITS BINDING EFFECT ON THEM** as well as me. **I AM AWARE THAT THIS CONTRACT IS LEGALLY BINDING AND THAT BY SIGNING BELOW I AM WAIVING MY LEGAL RIGHTS AS WELL AS THOSE OF ANY MINOR FOR WHOM I AM SIGNING.**
