

Salomon Extreme Freeride Championships at Taos

Cash purse of \$10,000 and prizes for the top male and female freeriders in the 3rd Annual Extreme Freeride Championships at Taos being held March 5th – March 8th, 2008.

Wednesday March 5th

Athlete Check-In and Welcome reception. Mandatory event meeting for all athletes at the welcome reception. This event is for all competitors and will be held at Taos Ski Valley's Martini Tree Bar starting at 6:00 pm.

Thursday March 6th

1st day of competition, entire field of competitors with the exception of pre-qualified athletes (1 run).

Friday March 7th

2nd day of competition, approximately half of the 1st day's field plus pre-qualified athletes (2 runs).

Saturday March 8th

Final day of competition, Top 31 competitors, 20 male, 5 female, 3 junior male and 3 junior female, will ski 2 runs. Awards party and banquet to be held at the Martini Tree Bar.

*Thank you for your interest in the **Salomon Extreme Freeride Championships at Taos**. Please read the packet carefully. From your packet, you will need to return the following pages: **Payment Information, Skier Profile, Model Release, Full and Complete Release of Liability and Indemnity Agreement and Valid Proof of Insurance**. Please mail or fax the forms back to us. **This event is a first-come, first-serve competitor registration. The competition will be limited to approximately 130 athletes.***

Please note: All athletes faxing in their registration will be expected to resign the liability release and model release from the registration packet as an original signature is needed on both documents. A \$25 fee will be charged for any returned checks or declined credit cards.

Freeskiing Championship Judging Criteria

Rated on a scale of 1 (lowest) to 10 (highest)

1. Line
2. Control
3. Fluidity
4. Form
5. Aggressiveness

Each category holds equal weight. However, the categories can have an effect on each other. For example, falling has a significant impact on categories 2, 3, 5 and possibly 4.

Specifics of Categories:

Line:

Each skier chooses his or her own line down the venue. Competitors are given high scores for choosing a difficult line. Difficulty is determined by steepness, exposure, snow conditions and obstacles or hazards, not how the athlete skis it. This category is scored first and must be discussed by all judges.

Control:

Skiers must remain in control; a fall is the ultimate loss of control. Any loss of control will result in a lower score. Both skis must cross the finish line.

Fluidity:

Constant direction toward a goal. This category includes continuity, pace, speed and smooth transitions through course sections.

Form/Technique:

Competitor is judged on style and technical ability. There are no standards. This is a category where the athletes impress the judges with their style and skiing beauty.

Aggressiveness/Attack:

Energy with which a skier attacks or descends his/her chosen line. Are they timid about the line? Or really focused and confident: skiing fast and strong?

The Freeskiing Competition

- **ALL COMPETITORS MUST HAVE PROOF OF INSURANCE OR THEY CANNOT COMPETE!**
- This event is first-come, first-serve, including pre-qualified competitors.
- Helmets are mandatory and must be manufactured for ski competition.

- The three categories for the event are:
Juniors – 14 – 17 years old (male & female)
Women – 18 and over
Men – 18 and over
- Venues will be decided the week before competition. The venue location for qualifying day will be announced at registration. The venue location for quarter-finals and semi-finals will be announced the morning of qualifying day. The venue location for the finals will be announced the evening of semi-final day. Only competitors remaining in the contest may inspect venues for the next day. Competitors cut from the contest who are poaching the next venue will lose their credentials and their lodging (if applicable).
- Male, female and junior fields are separate and will not compete against each other. We will allow for 20 juniors, 20 women and 90 male competitors. The purse for the fields may be different.
- Field size may vary according to female and junior participation. If the female and junior fields are below 20 participants in each category, the spots will be given to adult men on a first-come, first-serve basis.
- Total field size will be limited to 130 competitors (byes will not compete until quarterfinals).
- Byes are ONLY given to the top 15 male and 5 female IFSA point winners.
- The field will be cut on qualifying day to fulfill a 50-competitor quota for the men and a 10-competitor quota for the women for quarter-finals. Byes will be included at this time. Byes will not ski until quarter-finals.
- Bibs will be distributed randomly at registration.
- Competitors must have bibs on them whenever skiing at any time during this event.
- Start orders will be random on qualifying day. (Does not have to be consecutive bib order.)
- On March 6th, 130 competitors will compete in quarter-finals, 1 run. The fields will then be cut in half and 65 competitors will compete in semi-finals, 1 run.
- Semi-final competitors will run in reverse order of advancing quarter-final competitors.
- The final day will consist of 31 competitors, 20 men, 5 women, 3 junior males and 3 junior females (2 runs).

Scoring & Judging

- Line choice is considered the most important category and control is the second most important category.
- There will be 5 judges recommended by the IFSA. Each judge is responsible for judging every competitor in all of the 5 categories. Judges will score each competitor immediately following each run. Scores will be tabulated and posted immediately after each run. Scores will be determined as an average of all 5 judges' scores. Not to exceed 50 points.

- If a competition day consists of 2 runs there may be a field cut of competitors between the first and second run.
- Line choice score will be the first score the judges make. Line choice score is the only discussion allowed on the judges' stand.
- All other scores are directly related to line choice score. Scores in the other categories generally do not exceed line choice score by more than 2 points.
- Scores in the remaining categories generally do not exceed control points by more than 2 points.
- Air is not judged as a category.
- Not successfully landing air will have significantly negative impacts on judging each of categories 2, 3, and 5.
- Each course is assigned a generous time limit by the judges and the forerunners.
- This time limit will be communicated to the starter at the start of the venue. The time limit will also be posted at the bottom of the course.
- Competitors who do not cross the finish line in the allotted time will receive a zero score in every category.
- Competitors who do not cross the finish line with both skis will receive a zero score in every category.
- A race official/scorekeeper will be on the judges' stand to add up and total scores and record cumulative totals.
- If judges are separated throughout the venue due to length or terrain of the venue, the scores will be reported to the race official/scorekeeper via radio communication, confirmed and tabulated.
- There will be a finish line at the end of each run. A competitor's time will not stop accruing until this line is crossed.
- Competitors must make an effort to finish the run with all skiing equipment. If skis release, competitors must hike for their skis and cross the finish line within the time limit.
- All decisions made by the judges are final.
- Any day may be canceled by the judges due to weather and/or visibility.
- Competitor protests cost \$25 immediately following the competitor's run.
- It is the responsibility of the competitor to substantiate any protest.
- The technical delegate may grant a provisional rerun on a case-by-case basis only after the collection of the protest fee.
- Under no circumstance may a competitor protest to the judges.

- If a protest is unsubstantiated by the competitor it will be automatically denied.

This discounted competitor's ticket will be available the week leading up to the event, beginning Friday, February 29th, for all pre-registered competitors. You must be on the registration list to purchase the competitor's special tickets.

Locals

Competitors with a Taos season pass do not have to purchase tickets.

THIS IS A LIABILITY RELEASE - READ CAREFULLY BEFORE SIGNING:

I ACKNOWLEDGE AND REPRESENT that I am at least 18 years of age, I am a parent and/or guardian of the minor child identified herein (referred to as "my Child"), I have authority to enter into this release and indemnity contract on behalf of my Child, on my own behalf and on behalf of any other parent or guardian of my Child, and I do so **FREELY, FULLY AND WITHOUT RESERVATION.**

THE UNDERSIGNED, FOR MY CHILD, MYSELF AND ANY OTHER PARENT/GUARDIAN OF MY CHILD HEREBY REPRESENTS TO AND CONTRACTS AND AGREES WITH TAOS SKI VALLEY, INC. as follows:

I ACKNOWLEDGE UNDERSTAND AND AGREE that extreme skiing, free style skiing (with the possibility of aerial or off-snow maneuvers), ski racing and extreme skiing competitions, and related activities, including training, are **EXTREMELY HAZARDOUS** activities that have many dangers and risks, even more dangers and risks than are involved in alpine skiing, and may result in injury or death to my Child, and that I have made a voluntary choice to allow my Child to participate in the Event **DESPITE THE EXTREME RISKS** that it presents, recognizing that participation in the Event shall not in any way eliminate the risks of extreme skiing.

I REPRESENT AND WARRANT that: my Child is at least fourteen (14) years of age, he/she is a skilled and experienced skier, he/she is in good health, he/she does not have any special physical or health problems and I have made no special instructions regarding his/her participation.

IN CONSIDERATION of my above acknowledgements, representations and warranties and of TSV permitting my Child to participate in the Event, for my Child, for myself and for any parent/guardian of my Child, **I VOLUNTARILY AGREE TO ASSUME ALL RISKS OF INJURY, DEATH AND PROPERTY DAMAGE** which might be associated with or result from my Child's practice and training for and participation in this Event.

I AGREE it is my **SOLE RESPONSIBILITY** to view the venues of this Event **BEFORE** my Child participates and to not allow my Child to participate if the venues of the Event or adjacent areas or conditions are not to my satisfaction and further **I AGREE** as follows:
